Should also help in data processing and analysis.
- ii. Some of the Research Associates/Research Fellows should be associated with performing the roster duties in the CRS on a 24 x 7 basis

for real time data reception and analyses of data. The remaining five Research Associates will be assisting the senior scientist in various activities of the National Program.
